### Message from the Founder

Dear Bengalurigas,

For any political movement, or for that matter, any citizens' movement to sustain and scale, a strong base of supporters is extremely crucial. The larger the base of supporters, the greater the multiplier effect to amplify the voice and build greater visibility. Ultimately, the way we build the base and amplify the voice, can be the difference between winning and losing, between creating an impact and being an also-ran.

We are starting with the base of BNP Mithras we already have and are actively engaging with them to encourage them to contribute financially. We are also working hard towards getting BNP Mitras to influence a few friends from their network to support BNP too.

BNP will be launching an advertising campaign soon to augment the Party's visibility, which hopefully will also encourage our Mithras to connect with more people in their network. The power of the multiplier effect can be very significant.

Imagine if 1,000 BNP Mithras can connect with 10 people each and if they, in turn, can connect with 10 people each, we would straight away have reached 1 lakh people. Even more amazingly, if each of these people contribute even Rs. 1,000 each, we would have raised Rs. 10 crores! This would place us wonderfully well in our endeavour to achieve **BNP Mission 25 (our mission to win 25 out of the 225 wards in the BBMP election)**.

## CAMPAIGN UPDATES

(Developments on BNP's Ongoing Central Campaigns)

### BNP'S #IWontPay CAMPAIGN UPDATES

BNP started the 'I Won't Pay' online petition, in protest against the new charges unconstitutionally imposed by the Bruhat Bengaluru Mahanagara Palike (BBMP). Even as the petition is slowly but steadily gathering signatures (over 2,700 signatures as of 31st May 2025), a Core BNP Team went to meet with Deputy Chief Minister Sri. D.K. Shivakumar, BBMP Chief Commissioner Sri. Maheshwar Rao, and BBMP Special Commissioner (Revenue) Sri. Munish Moudgil, to submit a letter calling for a halt to the collection of Solid Waste Management (SWM) User Fee for this year.

At these meetings on 13th and 14th May 2025, BNP Founder and General Secretary, Srikanth Narasimhan, BNP Zonal Leader (Mahadevapura) Vishnu Reddy, BNP Zonal Leader (Bommanahalli) Lalithamba B V, BNP Head of Research and Media Team Sowmya Raghavan and BNP Leaders Jayant Nair and Swarupa, submitted a letter to halt the collection of SWM user fee for this year, highlighting 3 key issues:

1. The 'Bulk Waste Generator' option was introduced only around 20th April 2025. Many apartment residents had already paid the SWM User Fee along with their Property Tax and also paid the empanelled vendors – double payment for a service BBMP doesn't provide. This amount should be refunded to the payers.
2. Smaller apartments (under 100 units) use empanelled vendors but are not classified as 'Bulk Waste Generators'. They cannot opt out and risk double payment. They need to be exempted from the SWM User Fee too.
3. Vacant plots are charged SWM Fee despite no waste generation or BBMP service. Why? Many owners of vacant plots have already paid the Fee too, along with their Property Tax.



In a follow-up meeting on 31st May 2025, BNP Founder and General Secretary Srikanth Narasimhan and BNP Zonal Leader (Bommanahalli) Lalithamba B V met Bengaluru Solid Waste Management Limited (BSWML) CEO Dr. Harish Kumar. The following were the discussions and results from this meeting:

1. BNP Leaders updated that many citizens who fall under the 'Bulk Waste Generator' category had already paid the SWM User Fee even before the 'Bulk Waste Generator Category' option was implemented on the Property Tax portal. To this, Sri Harish mentioned that whoever has already paid can make a requisition and he will look at refunding or adjusting the same.
2. He mentioned that all Apartment Complexes with less than 100 units don't fall under the 'Bulk Waste Generator' category. Such apartments need to dispose off their waste through the BBMP.
3. **BNP's DEMAND is to REVERSE SWM USER FEE** for now, and implement it after due consultation with the citizens and elected Council. BNP requested to take up this matter with the higher ups.
4. Regarding the open site garbage issue, he said that it should be taken up with the SWM Assistant Executive Engineers (SWM AEEs) deputed from BSWML to monitor Solid Waste Management in each assembly constituency.

5. Regarding Waste Transfer Stations (from where the collected waste is shifted to processing/disposal sites), on Main Roads, BNP was told that the Commissioner has ordered that the Transfer Stations be shifted to inner sites, rather than on Main Roads. There is to be one Transfer Station per Assembly Constituency Ward.

NP hopes for a positive response from the officials. BNP will continue its fight until the unfair charges are removed and a transparent process is put in place.

If you too are appalled by the new Parking Fees and Garbage User Fees implemented by the BBMP, that is being run in an unconstitutional manner by the State Government instead of by elected BBMP Council / Corporators / Mayor, for the last 4.5 years,





### Namma Samiti (Ward Committee Meetings)

**Ward:** GOTTIGERE (194)

**Date:** 7th May 2025

**BNP Representatives:** BNP Zonal Leader (Bengaluru South) Poongothai Paramasivam, and BNP Area Sabha Members Swarupa Kakumanu and Farheen Taj.

**Discussion Points and Decisions:** BNP team brought up the civic issues listed in the BNP tracker — potholes, road tar resurfacing requests, Storm Water Drain (SWD) issues, drain cleaning requests, Solid Waste Management (SWM) concerns, park maintenance issues, non-working street lights, public health and safety issues, and traffic-related concerns.

These were all taken up for discussion. Officials responded that steps are being initiated to address these issues systematically.



**Ward:** HSR LAYOUT

**Date:** 14th May 2025

**BNP Representatives:** BNP Leader Roohi Akther

**Discussion Points and Decisions:** BNP Leader raised the following issues:

- Footpath on 24th Main, opposite the KEB Station – requested to reclaim and restore it to make it walkable
- Broken footpath tiles in front of Aishwarya East Woods Apartments on 24th Main – requested repair and alignment
- Debris inside the Sundaravana Lake drain – requested slabs to be laid over the open drain, as it is currently attracting garbage dumping by locals

BBMP officials assured that the tender process would be initiated shortly and action will be taken on the issues raised.

**Ward:** PUTTENAHALI (214)

**Date:** 21st May 2025

**BNP Representatives:** BNP Leader Ram with the BNP Team and residents from the Mayflower Block of the Brigade Millennium Apartment

**Discussion Points and Decisions:**

- Garbage dumping and the need for cleanup in the Brigade Millennium area
- School bus parking and reports of alcohol consumption near Brigade School
- Open smoking in the area next to Mayflower Apartment

Officials said that they will look into the matter.



BNP Leaders and BNP Area Sabha Members will continue to attend Ward Committee Meetings in different Wards, bringing up civic issues and following-up on them until visible improvements are made.

#### ONLINE eKHATA OVERVIEW SESSIONS

BNP continues to host online preliminary 'eKhata Procurement Overview Sessions'. These sessions typically start with an introduction to the BNP and the reason BNP is conducting the camp. Followed by an explanation of what the eKhata is, its features, the mandatory requirements for the same, BNP experts then share the list of documents required and directions on how to find the Electronic Property Identification Number (ePID), urging attendees to try and apply on their own for their eKhatas or, to coordinate with the BNP, form groups and get started together.

**Date:** 4th May 2025

**BNP Zonal Leader (Bengaluru South) Poongothai Paramasivam, BNP Area Leader Asha Nayak** and BNP Area Sabha Members Ajay, Murtuza, Saroj and Seeboli together went to Jyothi Nagar, Bohra Layout, Gottigere, to identify and document the civic issues in the area. They spotted and noted down several issues related to roads, drains, garbage, streetlights and tree trimming, all of which were to be compiled and formally submitted to the BBMP for necessary follow-up and remedial action.

The BNP Team also engaged in meaningful discussions with local residents to better understand their concerns and raise awareness about ongoing efforts. The Team sincerely thanks the residents who supported this initiative and look forward to even greater participation in the future.

[BNP's Press Release \(PR\) dated 1st May 2025](#) brought into focus Area Sabhas and how they have been completely left out in the recently implemented Greater Bengaluru Governance Act (GBGA). The PR titled — 'Area Sabhas: A Proven Model of Citizen-Led Governance That the New GBGB Law Has Ignored' quotes BNP Founder and General Secretary Srikanth Narasimhan "BNP made detailed submissions to the Rizwan Arshad Committee and repeatedly emphasized the need for legally recognized and strengthened Area Sabhas. The GBGB (now enacted as the Law - GBGA) has sidelined the concept. Instead of embracing decentralization and empowering citizens, the government has chosen to centralize power, stripping Bengaluru's residents of meaningful participation in their own governance". The PR presents how BNP has established Area Sabhas in multiple Wards and proven how Area Sabhas work effectively in the Urban context, resolving over 800 civic issues through structured community engagement, participatory planning, and consistent follow-ups with BBMP officials.

The second [PR for May 2025, dated 23rd May 2025](#) shared information about the running BNP's #IWontPay Campaign that has been started to rebuke BBMP's unilateral decision to levy and collect a new 'Garbage Usage Fee' along with the Property Tax collection. Many owners who do not fall under the category of 'Bulk Waste Generators', owners in Complexes with less than 100 units who take care of their waste through private vendors and owners of vacant sites have already paid this fee when they did not have to. "This is not just carelessness—it's exploitation. How can BBMP collect a fee without even knowing who should pay and who shouldn't? Shouldn't a government agency have the basic sense to avoid double-charging citizens for a service it doesn't deliver?" asks Srikanth Narasimhan, BNP Founder and General Secretary. The fact that this User Fee has been enforced without a Governing Council in place for over 4½ years, and without any consultancy with citizens, only makes more and more people (over 2,800 now) sign up for the BNP's Online #IWontPay Campaign.

## **Greater Bengaluru Authority Replaces BBMP**

The State Government has officially notified the formation of the Greater Bengaluru Authority (GBA), which now becomes the primary civic body replacing BBMP for the city's core functions. The new agency will oversee urban planning, infrastructure, waste management and public service delivery across the metropolitan region. This move aims to streamline governance, and address the fragmentation and inefficiency seen under BBMP's watch. While some experts welcome the shift as long overdue, questions remain about how this authority will coordinate with existing agencies. It marks a major structural change in how Bengaluru will be managed going forward.

## **Legal Undertaking to Control Construction**

Bengaluru's BBMP has introduced a mandatory legal undertaking for builders and property owners to curb rampant unauthorized constructions, signaling a tougher stance against violations. Under this new rule, applicants must affirm they will not exceed approved building plans before construction begins. This follows recent enforcement actions, including demolitions and BESCOM's support to identify power connections in illegal structures. By requiring upfront accountability, BBMP aims to deter rule-breaking before it happens, rather than reactively demolishing structures. Officials acknowledge that the undertaking will simplify enforcement and reduce the need for future legal actions. However, success will depend on strict monitoring, inter-agency coordination and transparent disclosure of enforcement metrics.

## **Cauvery Water Service via Tanker**

The Karnataka government has introduced the 'Sanchari Cauvery' initiative to supply BIS-certified Cauvery water through GPS-tracked tankers. The scheme offers real-time booking through a digital platform and ensures secure delivery via OTP verification to the customer's doorstep. To support affordability, the water is provided at subsidised rates, making clean water accessible to a larger population. This initiative aims to bring transparency, prevent water theft or pilferage and enhance the overall reliability of tanker water supply in the region.

## **Bengaluru Apartments Struggle with Governance**

Bengaluru's apartment complexes, which often function like mini-municipalities with annual budgets ranging from ₹5 to ₹20 crore, are facing increasing governance challenges. Resident Welfare Associations (RWAs) struggle with leadership gaps, lack of expertise, internal conflicts, and poor financial oversight. As a result, critical functions like maintenance, dispute resolution, and infrastructure planning suffer. Organizations like IIM Bangalore and the Bangalore Apartments' Federation (BAF) are stepping in to train residents and promote better models such as staggered leadership terms and decentralized block-level governance, but adoption remains limited. Experts warn that these governance issues could escalate into larger crises if ignored.

## **Exclusive Body for Major Projects**

Bengaluru has formally established a new Special Purpose Vehicle (SPV) with an initial corpus of ₹7,000 crore to accelerate major infrastructure projects across the city. This dedicated body will oversee large-scale initiatives, including a proposed network of 40 kms of underground tunnel roads, multiple flyovers and other strategic urban developments. By centralizing project planning and execution, the city aims to overcome bureaucratic delays and deliver on promised improvements faster. Stakeholders say this marks a shift toward focused and efficient implementation, though experts caution that sustained political will and transparency will be essential to realize these ambitious plans.

## **Hebbal Land for Infrastructure Projects**

Bengaluru is moving ahead to reclaim a strategically located 45-acre stretch in Hebbal for major infrastructure upgrades. The State Government, led by Deputy Chief Minister D. K. Shivakumar, has approved land acquisition to build an integrated transport hub featuring a Metro depot, tunnel roads and multi-modal connectivity, overcoming delays and real estate hurdles. Compensation is to be provided via TDR, FAR or other norms. Stakeholders, including MPs and urban planners, believe that this move will streamline key projects. However, its success hinges on smooth coordination, legal clearances and transparent planning.

## **Bellandur Lake Revival Gets a Boost**

The Karnataka Government has approved an additional ₹79 crore for the rejuvenation of Bellandur Lake, taking the total allocation to around ₹179 crore. This funding will support desilting, wetland creation and infrastructure to prevent sewage inflow. The move follows pressure from the National Green Tribunal (NGT) and experts from IISc, who highlighted the lake's toxic foam and ecological damage. The plan also includes restoring biodiversity and improving water quality. If implemented effectively, this could mark a turning point in addressing one of Bengaluru's most persistent environmental crises.
