### Message from the Founder

Dear Bengalurigas,

Let's talk about Property Tax with regard to Parking Area.

#### What is the issue?

BBMP started serving notices to thousands of property owners in Bengaluru, citing under-declaration / evasion of Property Tax, over many years.

#### What is the background?

Pursuant to citizens filling in their eKhata applications, BBMP has been citing a mismatch between property area declared in Property Tax payment vs the property area declared in eKhata application.

#### Why did the mismatch happen?

Many citizens have been paying Property Tax on Super-Built-Up Area (SBA) that is clearly mentioned in their Sale Deed, which is effectively what they own in their apartment. They have not been paying Property Tax separately on the Parking Area (PA). However, in the eKhata Application, BBMP asks for details of both SBA as well as PA (both of which are mandatory) which citizens have been filling in. BBMP is adding the SBA to the PA for each property and compares it with the Property Tax payment for the property which is only on SBA, and hence claims that there is a mismatch.

#### Does Super-Built-up Area include Parking Area?

As per some of the experts BNP has engaged with, Parking Area (PA) is generally not included in the Super-Built-Up Area (SBA). SBA includes only the Carpet Area and the Other Common Areas.

#### So, where does Parking Area fit in?

Here is a piece of interesting information, which might come as a shock to many people – Flat Owners do not own their Parking Area but only have the "Right to Use" the same! Most of the Sale Deeds have a clear wording on the same, which citizens usually miss and end up with the wrong assumption that they own their respective parking slots! If a Sale Deed has a wording that the Parking Area has been sold by the Builder to the Flat Owners, it is illegal!

#### How do we say that a builder "selling" a Parking Area to flat owners is illegal?

The Supreme Court of India has ruled that open and stilt parking areas are part of the building's common areas and cannot be sold. In the landmark case of Nahalchand Laloochand Pvt. Ltd. vs. Panchali Cooperative Housing Society, the Apex Court reaffirmed that parking spaces are meant for the common use of all residents and cannot be sold separately to flat purchasers. Furthermore, Section 2(n) of the RERA Act clearly defines Parking Areas as common areas.

## MESSAGE FROM THE FOUNDER

(Srikanth Narasimhan's Perspective on Topics of Current Relevance to Bengaluru & BNP)

### ***Does this mean that the flat owners do not own their Parking Slots?***

*That is correct. In most Sale Deeds, the wording is explicit that the owner only has the right to use. Even if the wording is different in a few Sale Deeds, the Supreme Court ruling and RERA make it clear that the Parking Slots cannot be sold and hence are not owned by the flat purchasers.*

### ***What is BNP's view on this issue?***

*BNP is of the clear view that Property Tax cannot be charged on Parking Areas. Parking Area is part of the common area, which in turn, is part of the SBA on which citizens are already paying tax. Even if someone were to argue that the Parking Area has not been included in the SBA by the builder, the tax is still not applicable, as the parking slot is not owned by the owners, as explained earlier. HOW CAN SOMEONE PAY PROPERTY TAX FOR SOMETHING THEY DO NOT OWN?*

### ***What is the recommended course of action by BNP?***

*BNP recommends that citizens who have received notices file an objection (for which BNP has already circulated a draft) with the relevant Assistant Revenue Officer (ARO). In addition, BNP recommends that citizens fill in the Parking Area as Zero in the eKhata Application, as they do not own the same. This will ensure that there is no mismatch between the eKhata & the Property Tax Payment details. BNP is separately engaging with BBMP to withdraw these notices.*

### BNP #IWontPay CAMPAIGN — MEETING UPDATE



As part of BNP's active, continued campaign against the additional Solid Waste Management (SWM) levies added by the Bruhat Bengaluru Mahanagara Palike (BBMP) to the Property Tax, high level BNP representatives met the Additional Chief Secretary to Government on 8th July 2025.

**Srikanth Narasimhan, BNP Founder and General Secretary and Poongothai Paramasivam, Governing Council (GC) Member and BNP Zonal President (Bengaluru South)**, met Additional Chief Secretary to Government of Karnataka, Urban Development Department (UDD) and BBMP Administrator Sri. Tushar Giri Nath. They updated him with all the details regarding SWM User Fee and BNP's demands, and requested him to reverse the SWM User Fee imposed in the Property Tax.

### 8000 PROPERTY TAX NOTICES WITHDRAWN

BNP is leading the fight yet again in yet another issue with Property Tax. This time, it is against the show-cause notices issued by the BBMP on property owners who had received their eKhata, citing 'mismatch between area declared for tax and area furnished for eKhata'.

In July, about 34,000 owners who had applied for and received the now mandatory eKhata started receiving show-cause demand notices for under-assessing their Property Tax. When the BNP team reviewed the notices, they found that in many cases, the variation between the owners' declared property values and BBMP's reassessment was less than 5%. Such differences fall within the legally permissible limit, meaning no further action was justified. Sure enough, days later, on 26th July 2025, BBMP sent an email to 8,000 owners that their show-cause notices had been withdrawn.

BNP believes that most of the remaining 26,000 notices may also be erroneous. Among the properties that received notices are those that left out the parking lot, which is also included in tax computation. **BNP Founder and General Secretary Srikanth Narasimhan** said the notices were based on a flawed calculation of Super Built-up Area (SBA). He said that "The SBA already covers common areas and parking spaces on which citizens have been paying tax. The BBMP is now adding the Parking Area again to the SBA, which is blatantly wrong,".

BNP re-emphasises that such arbitrary actions underline the need for transparency and accuracy in municipal governance, and will continue to follow up with the BBMP to ensure that the BBMP's tax-assessment processes improve to avoid unnecessary distress for law-abiding taxpayers.

### SAVE UTTARAHALLI LAKE



The Uttarahalli Lake is a good example of collaborative effort. A few years ago, the BBMP, the United Way Bengaluru (UWBe) and local residents, joined forces to revitalize the lake Uttarahalli Lake that faced severe issues including choking with weeds and water hyacinth, solid waste dumping, and sewage inflow. **Five new Corporations replace BBMP**

The Karnataka government has proposed replacing the Bruhat Bengaluru Mahanagara Palike (BBMP) with five distinct civic corporations — Bengaluru West City Corporation, Bengaluru South City Corporation, Bengaluru North City Corporation, Bengaluru East City Corporation and Bengaluru Central City Corporation, together covering the same 712 sq km as the BBMP. Each new corporation spans 78–168 sq km and includes 2–10 assembly constituencies. Bengaluru South will have 9 Assembly segments and will include revenue-rich Bellandur, while Bengaluru East will have only 2 Assembly Seats (Mahadevapura excluding Bellandur and Krishnarajapura). The Brand Bengaluru Expert Committee (BBEC) is said to have determined these divisions to optimize population distribution, infrastructure, Property Tax revenue and administrative feasibility.

**Peripheral Ring Road landowners demand justice**

Landowners whose land was preliminarily notified for acquisition over 20 years ago for the Bengaluru Peripheral Ring Road (PRR) project have formally submitted a petition to the BDA Commissioner. Citing an Indore Acquisition Ruling, they claim that the acquisition should be considered lapsed since no award of compensation has been issued within five years. They demand issuing a fresh acquisition notification under the LARR Act, 2013, compensation for economic and emotional harm caused by the delay, inclusion of affected landowners as equity stakeholders in upcoming commercial or township projects, and offering at least one government job per displaced family as part of a humane rehabilitation policy. They have warned that failure to act may push them to seek relief through the Karnataka High Court.

**Court Notice to BBMP over footpaths**

A division bench of the Karnataka High Court has issued notices to the State Government, the BBMP, and the Police in response to a Public Interest Litigation (PIL) filed by Bengaluru-based NGO Letzkit Foundation. The PIL highlights widespread encroachments on roads and footpaths across Bengaluru, such as gardens fenced onto pavements, large plant pots, business or religious extensions, parking, storage of construction materials, and construction of public toilets, transformers and water facilities on footpaths. The petitioner argued that despite BBMP's statutory duty to maintain thoroughfares, the reality remains contrary, with persistent obstructions continuing despite prior court directives.

**Makeover Plan for City Lakes**

Deputy Chief Minister D.K. Shivakumar has unveiled that the BBMP has earmarked ₹50 crore for the restoration of 24 'lost' lakes across the city. The funds will be allocated toward desilting, fencing, pathways, sewage diversion, and upgrades to inlets and culverts to improve public access and environmental resilience. Major beneficiaries include Kalkere Lake (₹10 crore), Kacharakanahalli Lake (₹3.5 crore), Siddapura Lake (₹1.75 crore), and Doddabidarakallu Lake (₹3 crore), while other lakes will receive between ₹75 lakh and ₹3.5 crore depending on their restoration needs. This initiative is part of a broader effort to revive Bengaluru's heritage as the 'City of Lakes'.

**OC Rule aggravates Housing Crisis**

Bengaluru's enforcement of the Supreme Court directive to deny power and water connections to buildings lacking Occupancy Certificates (OCs) has led to unintended chaos. Denied utility access, some owners resort to illegal power hookups and letting out sewage onto the roads. This affects other citizens in the area who have done everything legally, as well as the unwary homebuyers in illegal or unregularised constructions. There is a need to set in place better regulation and monitoring of constructions, especially the larger ones, to stop such illegal constructions at the start, and better-prepared, thoughtfully implemented methods to penalise the culprits.

**BBMP expands e-khata service providers**

The BBMP has expanded its e-khata service offerings by authorizing 300 local private entrepreneurs to assist property owners in obtaining their e-khata certificates. Previously, only Bangalore One centres and the government-backed Jana Sevaka platform could facilitate document uploads. This move aims to improve accessibility and reduce bottlenecks in the digitised property record process. It comes as part of the broader e-khata digitisation drive, which has made e-khata mandatory in Bengaluru, streamlining property transactions and enhancing transparency.

**BDA to Manage Sky Deck Project**

Bengaluru's ambitious Sky Deck, planned as a 250-meter observation tower and potentially South Asia's tallest, is now going to come up in Ramasandra village near Kommaghatta. The site promises better connectivity and fewer regulatory hurdles. Estimated to cost up to ₹500 crore, the BBMP was first tasked with preparing the Detailed Project Report (DPR) and identifying land, but struggled due to air traffic height restrictions. The Government later handed it over to Bengaluru Smart Infrastructure Ltd (B-SMILE), a special purpose vehicle for large scale projects, and now, has reassigned it to the Bangalore Development Authority (BDA). The site currently lacks direct access, especially from the NICE Ring Road. The BDA will need to construct a new road to enable private vehicle entry.
